Dr. Alkhal serves as the designated institutional official at Hamad Medical Corporation, in Doha, Qatar. Having received education in both Qatar and the US in internal medicine, he then completed a fellowship in infectious disease. He was instrumental in bringing ACGME International accreditation to his country and remains active clinically as well. Dr. Alkhal also served as an inaugural international member of the Review Committee-International.



Ms. Jillian Andrada is the institutional coordinator at SingHealth Hospitals in Singapore, with oversight of 34 residency programs and over 1000 residents. She has grown into this role after first serving as a program coordinator in emergency medicine when ACGME International accreditation first started. Her development of a Quarterly Residency Dashboard has evolved into a leadership program for all program directors at SingHealth; these projects have been awarded on multiple occasions.

Question of the Quarter

Each quarter, this section of the ACGME-I newsletter answers a different question applicable to all ACGME-I-accredited programs. This quarter's focus is on the Program Letter of Agreement (PLA). Two questions related to PLAs follow.

Question 1: How do I decide if I need a PLA for a rotation?

PLAs must be completed for any resident assignment that is a required rotation. If residents will be assigned to multiple sites to complete a required experience, each site must have a PLA in place that is specific to that site. For example, if half the program's residents are assigned to Site A and half are assigned to Site B to complete a required rotation, both A and B must have a PLA that is specific to that site.

PLAs are not required for internal rotations to other services or departments. For example, in pediatrics, the Advanced Specialty Requirements mandate that all residents have rotations in the Emergency Department. If all pediatric residents complete this required experience in the Emergency Room at the Sponsoring Institution, a PLA is not needed. Additionally, if residents are assigned to a specialty hospital (such as a cancer hospital, dialysis center, or ambulatory surgical center) governed by the Sponsoring Institution, a PLA is not needed.

Question 2: How specific should a PLA be?

The PLA must be specific when naming faculty members, listing faculty member responsibilities, indicating the duration of the assignment, outlining the content and objectives of the experience, and stating the policies and procedures that govern the assignment. Many Sponsoring Institutions will use templates to help guide the program director when writing PLAs. This can be very useful, but be careful that all of the required items are in place and specific

to the program/site. It is important to carefully proofread sections that were 'cut and pasted' from another document to make sure these parts fully apply to the specialty, and specific assignment at that site.

Review Committee-International News



The Review Committee-International meeting was held 7-9 December in Singapore. The Committee reviewed submitted material and site visit reports for nine program applications and from eight programs and Sponsoring Institutions that are currently accredited. The Committee also reviewed progress reports and requests for complement increases.

For the first time, residency programs in dermatology, neurological surgery, and radiation oncology received accreditation. The ACGME-I now accredits 149 residency and fellowship programs, marking a 10 percent increase in the number of accredited programs in 2017.

At its business meeting, Review Committee-International members carefully considered comments received during public comment and used them to inform revision and approval of new Advanced Specialty Requirements for Clinical Informatics and to the requirements for Family Medicine Practice (FMP) sites in the Advanced Specialty Requirements for Family Medicine. The Committee also discussed possible revisions to the Advanced Specialty Requirements for Pathology related to the minimum number of autopsies required; scholarly activity requirements for fellowship programs; and the faculty qualifications currently outlined in the ACGME-I Foundational Requirements. Any proposed revisions to these requirements and additional new fellowship requirements will be posted for public comment in spring 2018. Designated institutional officials (DIOs), program directors, faculty members, and coordinators should watch their e-mail for notices from the ACGME-I when requirements are posted for a 60-day public comment period.

Finally, the Committee honored three members who have completed their terms on the Review Committee-International.

- **Dr. Margaret Blott** is currently Chair of the Department of Obstetrics and Gynecology and DIO at Corniche Hospital in Abu Dhabi, United Arab Emirates. She is the former program director for Corniche Hospital's obstetrics and gynecology residency program.
- **Dr. Sally Ho** is currently Assistant Director for Education and a Senior Consultant in the Family Medicine program at Singapore Health Services. She is the former program director for SingHealth's family medicine program.
- **Dr. Halah Ibrahim** is currently Executive Director of Health and Wellness at New York University, Abu Dhabi. She is also currently a member of the Editorial Board for the Journal of Graduate Medical Education. Dr. Ibrahim is the former DIO of Tawam Hospital in Al Ain, United Arab Emirates.

Each of these physicians was responsible for transitioning their program or institution to ACGME-I accreditation, and they were members of the first group of physicians to truly represent the international voice in the important peer-driven process. Their collective expertise and dedication to graduate medical education within their institution, program, and especially within their country is unparalleled. All will be missed.
